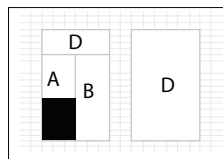

## 4.2 Visa Regulations

- Exhibitors and visitors from countries listed below, can have their entry visas obtained upon arrival at Kuwait International Airport.
- Exhibitors and visitors from restricted countries [NOT listed below] must complete this application and Fax back to the organizers along with a photocopy of their passport.
- Entry permission processing charges is US\$ 50 per person [Individual & Groups].
- Procedures take 10 working days.

Visas to Kuwait or entry permissions are issued at the entire discretion of the Kuwaiti authorities, but if an exhibitor experiences difficulty in obtaining visa, the organizers will do their utmost to assist, In all cases, the organizers cannot be held responsible if the visa application was not approved.

### **Kuwait will grant the following 34 nationalities entry visas upon arrival:**
